Pat made a motion to approve the July 26th meeting minutes, second by Danny

Discussion continued on the Legal editorial report.

40. Committee was okay with suggested changes to the 130.08 curfew regulations.

41. 130.13 Mike noticed that the updated vaping wording was not included in the draft. Carrie will look into this.

42. 150.01 Wi stat 66.058 was no longer found. Carrie suggested maybe chapter 58 would work for this section. Will ask the village attorney if agrees.

43. Committee did not agree with the suggested changes to this residential area ord.

44. Committee agreed to the changes in 151.038 LIC. (both a, and b) wording added the following permitted uses, and following prohibited uses.

45. 151.038 Committee was in agreement with the version used passed on 11-08-2004.

46. Committee was ok words add to 151.040 the following are conditional uses.

47. Committee agreed that work need to be done to the zoning ord, agreed to leave as is for now.

48. 151.058 Committee agreed to the suggested new state statute number 66.0413 (1)(b) be used to replace 66.05(5), as this was no longer found.

49.50. 51. Committee agreed to make the suggested changes. Mike has agreed to work on getting these changes ready.

52. Add the wording provision of the ordinance and change 151.098-151.08 to 151.08 - 151.098. Committee agreed.

53. Committee was okay to change 152.31 Floodway ord. **Code ch. COMM 83 to NR 116.**

54. 152.32 Committee was okay with the change suggested the same as stated in **comment 53 above**.

55. 152.34 Committee was okay with the changes suggested, same as in **comments in 53 stated above**.

- COMM 83 is no longer found in the state Administrative Code.

56. Ch 152 map committee agreed to ask Roy if he would have a better map to be submitted to replace the tinny one currently being used.

57. 153.04 WI dwelling code. Committee was okay with suggested changes COMM 20 to 25 which needs to be updated to align with current administrative regulations., to be changed to SPS 320 to 325.

58. 153.07 Building Permit fee committee agreed to replace COMM 2 which is no longer found in the state Administrative code. Agreed to change to SPS.
