MINUTES

- 1. Call meeting to order. Randy Kallstrom called the meeting to order at 10:00 AM.
- 2. **Roll Call –** Members present were Randy Kallstrom, Mike Michaud, Vicky Kosok, Steve Westman, Paul Riesgraf, Aaron Kallstrom. Also present Jesse Van Alstine, Paul Worth, Kevin Sandwick, Dennis Bemish arrived later in the meeting.
- 3. **Approval of 05.04.2023 meeting minutes –** Paul Riesgraf made a motion to accept the Draft Minutes, motion seconded by Vicky Kosok. Motion passes.
- 4. Winter access to the waterfront area for motorized vehicles- Steve Westman discussed the sign the Marina had put up at the Yacht Club access to the breakwater area that says Authorized Vehicles Only. He indicated that this action was outside of their authority as the they cannot block access to a public right of way, Lake St that extends to the water's edge. There was considerable discussion about the subject. Mike Michaud made a motion to keep open access to the breakwater by the Yacht club throughout the wintertime, restricted to no automobiles beyond the point where boats are parked, and to install two signs spaced less than an automobile width saying no automobiles beyond this point and enter at your own risk, the signs would go up after a significant snowfall. Motion seconded by Randy Kallstrom.
- 5. **Additional Plowing-** Randy made a motion to recommend that the board approve not charging for parking at the Sportsman's Landing parking area from December 1st through April 1st. The motion was seconded by Vicky Kosok. Motion passes. Steve Westman made a motion to hire outside service to plow one lane only starting in December, Harbor Drive from Lake Street entrance to Marina building, and contingent upon that we use the funds in the Sportsman's landing fund. Motion seconded by Mike Michaud. Motion passes. Steve Westman made a motion to hire out plowing of Sportsman's landing parking area and use money from the Sportsman's landing fund to pay for it. Seconded by Mike Michaud. Motion passes.
- 6. **Streets Update** Randy discussed speed limits on 2nd St now that the nursing home is running again. He said the previous signage would be put up. Kevin Sandwick stated that the alley between Dunn and Prairie, and between Sixth and Seventh needs some work.

7. **Adjourn –** Randy Kallstrom made a motion to Adjourn, seconded by Paul Riesgraf. Motion passes.
